


LMC Pavilion - Atrium Elevation




LMC C Tower Backfill

- Renovate C Tower North
 - \$ 8,500,000 FY2021 New LMC MOB C Tower 1st, 2nd & 3rd¹
- \$ 1,600,000 FY2020 Renovate LMC C Tower 5th & 6th²
- \$ 10,100,000 Total C Tower Backfill
- ¹ Convert 40,000 SF of LMC C Tower North (1st, 2nd & 3rd Floor), into an on campus MOB. Connect directly to parking garage via a sky-bridge. Possible inclusion of Urgent Care Clinic.
- ² Relocate North C Tower business/offices to converted 5th & 6th floor. New business spaces to be most efficient in use of SF/FTE.




- Renovate vacated Endoscopy Department




LMC B Tower Backfill







LHN GME Renovation

- GME Department LHN LL Education Floor
 - \$ 450,000 FY2020 Renovation- GME Department¹
- Renovate 3,429 SF of existing storage rooms and GME classroom into contiguous GME department. Final space allocation includes: Multi-Purpose/Lecture Room, Interview/Meeting Rooms, Lockers and On Call Rooms, Break Area and Gang bathrooms.

- Replace Cardiology Building at LHN Campus
 - \$ 3,000,000 FY2022 New Cardiac Building MOB¹
- \$ 2,500,000 FY2021 Purchase 24 N. St. Joseph, Niles²
- \$ 500,000 FY2021 LHN Campus Upgrades³
- \$ 6,000,000 Total Cardiology Building
- ¹ Raze existing Cardiology building and replace with new 10,000 SF medical building.
- Purchase 24 N. St. Joseph, (Niles) MOB for temporary placement of LHN Cardiology practice. Lease at profit after new Cardiology Building is complete.
- ² Raze 60 N. St. Joseph MOB Building and install parking to serve, MOB, Cardiology and LHN.




SWMC Niles Building

- Replace SWMC Building at 11th Street, Niles
 - \$ 2,500,000 FY2019 New SWMC Niles Building MOB¹
 - Build new 15,000 SF, 10 provider SWMC building, then raze existing building. Campus will accommodate multiple practices and entrances. Balance of site is good opportunity for an Urgent Care Center or a Medical Specialty practice building.



- ⁴ Existing Central Scheduling Center Building is significantly beyond end of life. Needs to be replaced or relocate services.


